

# RESOLUTION No. 2023-003

A RESOLUTION OF THE UPPER CAPTIVA FIRE PROTECTION AND RESCUE SERVICE DISTRICT OF LEE COUNTY, FLORIDA, ESTABLISHING THE MAXIMUM LEVY OF AD VALOREM TAXES IN LEE COUNTY FOR FISCAL YEAR 2023-24 FOR TRUTH IN MILEAGE AND DR-420 FORM PURPOSES, ESTABLISHING THE DATE, TIME AND PLACE FOR THE TENTATIVE (FIRST) PUBLIC HEARING ON THE PROPOSED MILLAGE AND THE BUDGET AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the gross taxable value for operating purposes not exempt from taxation within Lee County has been certified by the county property appraiser to the UPPER CAPTIVA FIRE PROTECTION AND RESCUE SERVICE DISTRICT as **\$299,468,306**.

NOW, THEREFORE, BE IT RESOLVED by the UPPER CAPTIVA FIRE PROTECTION AND RESCUE SERVICE DISTRICT of LEE County, Florida, that:

1. The proposed Fiscal Year 2023-2024 operating millage rate for purposes of the District's Truth in Millage (TRIM) disclosure requirement and for the purposes of the District's DR-420 Form filing requirement is 3.15 mills, which is 12.5 % greater than/less than/equal to the rolled-back rate of 2.8007 mills.
2. The Date, Time and Place of the FIRST public hearing to ADOPT the TENTATIVE levy of the Fiscal Year 2023-2024 Millage Rate and the Budget will be **Saturday, 9<sup>th</sup> September 2023 at 10:00 a.m.** at the Upper Captiva Fire House, **4511 Hodgepodge Lane, North Captiva Island, Florida.**
