WHEREAS, the gross taxable value for operating purposes not exempt from taxation within the District has been certified by the Lee County Property Appraiser to the Upper Captiva Fire Protection and Rescue Service District as **\$323,331,468**.

NOW, THEREFORE, BE IT RESOLVED by the Upper Captiva Fire Protection and Rescue Service District of Lee County, Florida, that:

1. The Fiscal Year 2024-2025 tentative operating millage rate is 3.6214 mils which is 24.4% percent greater than/less than/equal to the rolled-back rate of 2.9114 mils.
