1) Call to Order:

5) New Business

ADDED: 4491 Cutlass Fire. Preliminary report and public comment/Q&A

Chief Jesse gave a preliminary after action report of the events on Jan 13, 2026. Jesse stressed that his statements were preliminary. Final report will be provided at the February 20 meeting.

Public comments were numerous.

Questions/issues centered around the following:

- What caused the original fire? (Best information points to Golf Cart being charged under the house).
- What caused the re-ignite (Fire re-started in attic and quickly spread across entire structure)
 - Why was this not detected (Attic area was probed and a thermal imaging heat detector was used did not indicate any heat in space when original scene was secured at ~2:00)
 - Did opening windows to vent interior smoke damage a contributing factor?
- Why did the department staff leave the scene unattended between 2:00 - 6:30PM.
 - Smoldering fires should be monitored more closely.
 - Policies must be changed to ensure people are on-site for extended periods post fires
- What were the equipment issues and what impact that have on the response to the fire. (Crack in pump that disabled tanker truck reduced amount of portable water available to fight fire. Pump was less than 9 months old; manufacturer has agreed to replace it)
- People asked for a better timeline of events. Specifically, between 2:00 – 7:00 (this will be part of the final report available in February 20 meeting).
- More community involvement is required!
 - More CERT members, and better coordination during emergencies
 - Community groups to assist with door-to-door alerting nearby houses
 - Crowd control a major issue (keeping spectators away from scene)
- What preventive measures can residents take to avoid similar issues
 - Charging all carts maximum distance away from houses.

- Routine maintenance by qualified mechanics (maintain water level in lead acid batteries, check terminals, wiring, chargers).
- Check/replace electrical outlets that may have been damaged by flooding.
- No Lithium batteries (note: both August and now Jan 13 fires were caused by standard lead-acid batteries)
- Sprinkler heads above golf carts
- Fire suppression system in battery compartments
- Fire extinguishers near golf carts.
- How can the community assist the department staff during emergencies going forward.
- How can we address the water issue(s) to ensure increase the fire fighting capabilities on the island.
